Resolved not to grant study leave to Dr. Narendra Maddu in order to allow him to avail the benefit of Raman Fellowship for Post Doctoral Research in U.S.A., as he is not a permanent employee of the University, his appointment was not approved by the Executive Council and he suppressed and misrepresented the facts. The resolution may be communicated to the Honourable High Court of Andhra Pradesh and Telangana, the University Grants Commission and the host University in U.S.A.

The Resolution was passed after having considered the entire situation in the light of the following facts:

The Letter of Dr. Narendra Maddu requesting for study leave along with the order of Honourable High Court dated 28-7-2016 of vacate stay Petition No.2676/2016 in W.P.No.22299/2016 was carefully examined taking into consideration the entire situation, as detailed below:

- 1. The then Vice Chancellor without the approval of the Executive Council and against to the provisions of the University rules and regulations appointed 21 Assistant Professors in the various Departments in respondent S.K. University, Ananthapuramu on 27-01-2010 subject to approval of the Executive Counsel. When the matter was placed before the Executive Council on 06.02.2010, the Executive Council disapproved the appointments in which the petitioner herein is one among them.
- 2. The Chancellor of the University, Governor of AP having taken serious note of the unauthorized action of the VC, appointed Justice A. Hanumanthu as the enquiry authority. He submitted his report on 30-8-2010, based on which the then VC was removed from office.
- 3. Meanwhile the petitioner and 20 others has approached the Honourable court and filed W.P.No. 14101 of 2010, which was disposed off with some directions. The University appealed against the order of the single judge.
- 4. The petitioner and 20 other Assistant Professors have approached the Hon'ble High Court in W.A.M.P.No.1793 and 1807/2011 in WA Nos. 760/2011 and 766/2011, and the order is read as follows:

"Hence, we are of the prima facie opinion that the scope and ambit of the powers of the Vice-Chancellor or the Executive Council with regard to appointment of Assistant Professors are required to be decided in the main



writ appeals. Therefore, we are inclined to suspend the operation of the impugned order of the learned single judge".

The Government is at liberty to take its decision, pursuant to reference of the matter by the Executive Council to the Government. However, any decision taken by the Government shall be subject to the result of the Writ Appeals. Till the Government takes a decision, the Assistant Professors, who have been functioning as on today, shall continue and their salaries shall also be paid. Any decision of the Government shall be subject to further orders"

- 5. Accordingly, the Govt. instructed the University to issue show cause notice to Dr. Narendra Maddu and 20 others as to why his services should not be terminated, and the University authorities issued show cause notice vide EC resolution dated 27-6-2012. Without giving reply, the petitioner and 20 others filed a writ petition (No.21177 of 2012) in the Honourable High Court. He is continuing in the University as per the interim order.
- 6. There is no direction in the above said Writ Appeals (W.A.M.P.No.1793 and 1807/2011 in WA Nos. 760/2011 and 766/2011) that the Petitioner and 20 others are entitled for all the benefits available to a permanent employee. The Petitioner and other 20 employees are not given any benefits available to the permanent employee by virtue of the directions in W.A. as the Hon'ble Court directed to continue and pay the salaries.
- 7. As such, the petitioner and 20 others are not extended the benefit of UGC revised pay scales for which pre-audit is required that could be done only when their appointment is approved by the Executive Council. For the same reason, the petitioner and 20 other employees are not extended the benefit of coverage under Contribution Pension Scheme, Career Advancement Scheme and other benefits meant for permanent employees.
- 8. Dr. M. Narendra Maddu applied for Raman Fellowship offered by UGC meant only to permanent employees, online. As per UGC guidelines on application for Raman Fellowship for the year 2015-2016, the petitioner has to attend for Personal Interview of the short-listed candidates. The University has not given any permission to the petitioner to attend personal interview on 12-01-2016.



But, the petitioner has attended the interview on 12-01-2016 without the knowledge of the University.

9. He approached the High Court (W.P.No.22299 of 2016), and misled the Honourable High Court, University authorities including UGC and host University by suppressing the actual facts.
